



FEATURE FILM LICENSE CONTRACT

This license agreement, made by and between TETON GRAVITY RESEARCH, LLC (hereinafter referred to as "TGR") and **IP NAME**

TO BE FILLED OUT (hereinafter PROMOTER), for a premiere in **IP FILL OUT**.

WITNESSED:

- TGR licenses to PROMOTER and PROMOTER hereby licenses from TGR, TGR's film **PRESSURE DROP** ("The Film") for up to two total showings over a two-day period, with timing to be mutually agreed upon.
- PROMOTER agrees to pay TGR a non-refundable deposit of **\$500.00** USD to be received within 14 days of the signed contract.
- PROMOTER agrees to pay **30%** of total ticket revenues, less the amount of the paid deposit. If the % of total ticket revenues is less than the deposit, then no further payment will be owed.
- PROMOTER agrees to provide a completed reconciliation form with final settlement within 10 business days of the completion of the premiere. If reconciliation is NOT received by said date the promoter will be billed at Capacity of the venue at 30% at \$25 per tickets. **INITIAL _____**

PROMOTER OBLIGATIONS:

- The Film must be billed as "**Teton Gravity Research presents PRESSURE DROP**" in marketing and on venue marquees. Teton Gravity Research may be shortened to TGR where necessary.
- PROMOTER agrees to play the film in full, including pre-recorded introduction and pre-roll, unless otherwise approved by TGR.
- PROMOTER agrees to complete reconciliation form, and final payment, within 10 business days after the showing of the Film.
- TGR's national sponsors receiving product exclusivity must be included in all film-specific advertising and PA announcements. Where possible, and where sponsors desire to be involved, space shall be provided to sponsors for product display or distribution, banners and other forms of advertisement at the premiere. National sponsors for **Pressure Drop includes Nissan, Tin Cup Sun Cruiser, please contact us if you have local sponsors that might be considered a conflict**. TGR reserves the right to add national sponsors.
- PROMOTER may not solicit any additional funds from national sponsors.
- PROMOTER agrees to utilize TGR's digital platform for data capture and for any prize giveaways. This is a digital platform for entries that is promoted on screen, and during pre-film introductions.
- PROMOTER shall not include any other video presentation prior to, during, or after the Film without express prior written consent of TGR, including any local sponsor promotional materials or commercials.
- PROMOTER acknowledges and agrees that i) The Film and all marketing materials sent are protected by U.S. and International Copyright Laws; ii) TGR is the sole and exclusive owner of the Film and all associated copyrights; iii) Nothing contained in this Agreement shall be deemed a license of the Film beyond this one event screening; iv) PROMOTER shall not use any of TGR's intellectual property except as explicitly agreed to in writing by the TGR; v) PROMOTER is responsible in ensuring that materials sent and the DVD/digital copy is not copied, duplicated, or loaned to any person while in its possession. If the DVD/digital link is copied or duplicated through the mishandling of the PROMOTER, it may be subject to litigation and shall be responsible for all legal fees incurred. PROMOTER agrees that it shall not authorize any other screening, sharing, or posting of the Film outside of the scope of this contract. Should a violation of any of the above be determined, PROMOTER acknowledges that this presents a risk to TGR's business model TGR shall have the right to seek injunctive relief and monetary damages against Promoter. In other words – **DO NOT SHARE THIS FILM IN ANY WAY EXCEPT AS CONTEMPLATED IN THIS CONTRACT**.
- PROMOTER shall destroy or return, at TGR's request, any materials after the screening within 10 days after the screening.



TGR OBLIGATIONS:

- TGR shall have the Film delivered DIGITALLY to the PROMOTER'S email address and PROMOTER agrees to examine the Film copy immediately upon delivery. If PROMOTER is not satisfied with the quality of the Film, PROMOTER must notify TGR within 2 days of receipt and TGR shall use best attempts to remedy the situation. TGR shall not be responsible for any lost opportunities by PROMOTER.
- TGR to give access to PROMOTER to the Feature assets,, which includes ad slicks, press releases, photos, fliers, postcards, web banners, radio ads, trailers and logos. ACCESS WILL ONLY BE PROVIDED TO PROMOTER WHEN CONTRACT AND DEPOSIT SECURED AND SHOW DETAILS ARE RECEIVED.
- TGR will support promotional efforts where possible / as requested, including promotions through the TGR social media platform (website tour pages, facebook and twitter), but shall not be obligated to do so.

ADDITIONAL PROMOTER CONTRACT OBLIGATIONS:

- Any promoter with an outstanding balance thirty (30) days following their show date will be subject to liquidated damages in the amount of 5% of the show's gross receipts. Interest on any unpaid balance, including any liquidated damages, will accrue at the rate of 1.5% per month beginning thirty (30) days after the show date.
- If PROMOTER fails to provide TGR with a completed reconciliation form, it shall be deemed that PROMOTER sold a ticket for each seat in the venue at the highest ticket price, and that amount shall be the basis for the revenue split payable by PROMOTER to TGR forthwith.
- PROMOTER will not show the Film or any part thereof at any place or time except as set forth in this contract. There shall be no television showings of any kind or nature. Furthermore, PROMOTER does not authorize the Film to be copied, videotaped, or otherwise reproduced in any form, and PROMOTER shall notify the audience of such and take precautions as necessary to ensure there is no videotaping at the screening.
- PROMOTER will use the Film in a careful and proper manner and will not make any alterations, modifications, or additions to the Film. Furthermore, PROMOTER will not assign, transfer, pledge or hypothecate this agreement, or any interest thereof, or sublet or lend the Film or any part thereof, or permit the Film to be used by anyone other than the PROMOTER. PROMOTER shall have no right, title or interest herein or thereto except as expressly set forth in this Agreement.
- If PROMOTER fails to abide by provision of this Agreement, or TGR determines that the Film is being used in any way or manner detrimental to TGR, TGR may take possession of Film without demand or notice, where-so-ever same may be located, without any court order or other process of Law. PROMOTER waives any and all damages occasioned by such possession.
- PROMOTER shall pay all costs and expenses, including reasonable attorney fees incurred by TGR, in exercising any of its rights or remedies herein or enforcing any of the terms, conditions, or provisions hereof. All the terms, conditions and provisions of this Agreement shall be interpreted in accordance with the Laws of the State of Wyoming and any dispute arising from the breach of any of the conditions shall be determined in accordance with those laws in the jurisdiction thereof.
- TGR will not indemnify PROMOTER for any acts of negligence or omission by PROMOTER or any of its agents, contractors, or employees in the course of all promotion, execution of event and all items herein.
- It is understood and agreed, that if by reason of fire, casualty, lockout, riot, strike, labor conditions, unavoidable accident, war, Act of God, enactment of any municipal, state or federal ordinance of law or other causes of peculiar nature beyond TGR's control, TGR's obligations may be postponed for the period of such delay.

PROMOTER AGREES TO THE TERMS AND CONDITIONS AND UNDERSTANDS THERE ARE NO AGREEMENTS OR WARRANTIES, EITHER EXPRESSED OR IMPLIED, AS TO ANY MATTER WHATSOEVER EXCEPT AS SET FORTH HEREIN AND ON SUBSEQUENT PAGES IN CONTRACT TO LICENSE TGR'S FILM. THIS CONTRACT SHALL NOT BE DEEMED VALID UNTIL DEPOSIT HAS BEEN RECEIVED BY TGR IN ACCORDANCE WITH ITEMS 2 AND 3 OF THIS AGREEMENT.
